

Stormwater management fees are based on the Cost Allocation Model and Stormwater Rate Model. Infrastructure is proposing a 3% increase in 2023 on residential and non-

residential fees. This will increase the residential fee from \$5.89 per residential unit per month to \$6.07. For non-residential uses, this base rate is multiplied by an area factor, and so the non-residential fee will be raised according to lot size.

Infrastructure is proposing to include Residential Call & Haul Dumpster Rental in the Comprehensive List of Fees to reflect current City practices of the Solid Waste division. Infrastructure is also proposing an increase to the fees currently charged to cover the increased costs of diesel fuel, manpower, and vehicle replacement.


Proposed wastewater fees are based on the Cost Allocation Model and Water and Sewer Rate Model.

Infrastructure is proposing to increase total revenue by 6% for the Water & Sewer system in 2023. Single Family Residential, Multi-family, Commercial, and Industrial rates will increase by 6%. The predominant cost drivers for these increases include increases in

debt service payments, as well as increasing costs to rehabilitate and replace aging infrastructure in both operations and maintenance budgets and capital projects.

The fiscal impact on the average single-family residence (service charge and usage) will increase from \$49.64 per month in 2022 to \$52.61 in 2023 when based on an average consumption of 542 cubic feet (CF).

Proposed water fees are based on the Cost Allocation Model and Water and Sewer Rate Model.

Infrastructure is proposing to move Single Family Residential water rates from an inclining 3-block to an inclining 4-block structure. This change is intended to promote affordability and equity. Costs will shift from lower-use customers to higher-use customers who are placing greater demands on the system primarily through summer irrigation.

Infrastructure is proposing to increase total revenue by 6% for the Water & Sewer system in 2023. Single Family Residential customers will experience a range of impacts as this increase will be applied to the new 4-block structure. Multi-family, Commercial, and Industrial rates will increase by 6%. The predominant cost drivers for these increases are debt service payments, new federal regulatory requirements, as well as increasing costs to rehabilitate and replace aging infrastructure in both operations and maintenance budgets and capital projects.

The fiscal impact on the average single-family residence (service charge and consumption) will decrease from \$33.97 per month in 2022 to \$33.40 in 2023 when based on an average consumption of 588 cubic feet (CF).


Proposed Water fees are based on the Cost Allocation Model and Water and Sewer Rate Model.

Infrastructure is proposing to align all Water Service Charges with AWWA standards. This is to ensure that each meter size is charged a fixed cost proportional to the meter's ability to use the water system's resources.

Infrastructure is proposing to increase total revenue by 6% for the Water & Sewer system in 2023. Single Family Residential, Multi-family, Commercial and Industrial rates will have a range of impacts based on the realigned fixed costs.

The fiscal impact on the average single-family residence (service charge and consumption) will decrease from \$33.97 per month in 2022 to \$33.40 in 2023 when based on an average consumption of 588 cubic feet (CF).

Water service rates for wholesale customers are based upon the Cost Allocation Model and Water and Sewer Rate Model.

The City of Olathe negotiates wholesale contracts for Water Districts. The current fee is \$3.71/100 cubic feet in 2022. If not otherwise contracted with the City, Public Works is proposing to raise the rate, including the service charge for water meters by 10% in 2023.

Currently, the average monthly bill is \$100 amounting to a \$5 late fee which has not shown to discourage late payments. 10% would be noticeable but not so much to be a cost inhibitor in being able to get account current. Gardner and Shawnee charge 10% and Prairie Village charges \$10.

The initial fee is proposed to be increased to \$500. After the TCO is closed and the final Certificate of Occupancy is issued, \$400 will be refunded to the applicant. This creates an incentive for permitees to obtain final inspections and close permits.
