

**ORDINANCE NO. 24-32**

**AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF OLATHE, KANSAS, AS ADOPTED BY REFERENCE IN SECTION 18.20.030 OF THE OLATHE UNIFIED DEVELOPMENT ORDINANCE; FURTHER AMENDING SAID SECTION 18.20.030 BY REINCORPORATING SUCH MAP AS AMENDED.**

**WHEREAS**, Rezoning Application No. RZ24-0005 requesting rezoning from the CTY PEC-3 (County Light Industrial) District to the R-1 (Single Family), R-2 (Two-Family), R-3 (Low-Density Multifamily) and M-2 (General Industrial) Districts was filed with the City of Olathe, Kansas, on the 14<sup>th</sup> day of February 2024; and

**WHEREAS**, proper notice of such rezoning application was given pursuant to K.S.A. 12-757 and Chapter 18.40 of the Olathe Unified Development Ordinance; and

**WHEREAS**, a public hearing on such application was held before the Planning Commission of the City of Olathe, Kansas, on the 22<sup>nd</sup> day of July 2024; and

**WHEREAS**, said Planning Commission has recommended that such rezoning application be approved.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OLATHE, KANSAS:**

**SECTION ONE:** That the Zoning Map of the City of Olathe, Kansas, is hereby ordered to be amended insofar as the same relates to certain parcels of land legally described as:

COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 13; THENCE N 87°52'31" E, ALONG THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 13, A DISTANCE OF 1191.68 FEET TO THE POINT OF BEGINNING; THENCE N 1°45'34" W, A DISTANCE OF 435.21 FEET; THENCE NORTHERLY ON A CURVE TO THE RIGHT, SAID CURVE BEING TANGENT TO THE LAST DESCRIBED COURSE AND HAVING A RADIUS OF 1000.00 FEET, AN ARC DISTANCE OF 364.71 FEET; THENCE N 19°08'12" E, A DISTANCE OF 351.47 FEET; THENCE NORTHERLY ON A CURVE TO THE LEFT, SAID CURVE BEING TANGENT TO THE LAST DESCRIBED COURSE AND HAVING A RADIUS OF 500.00 FEET, AN ARC DISTANCE OF 182.35 FEET; THENCE N 1°45'34" W, A DISTANCE OF 385.16 FEET; THENCE N 89°52'09" E, A DISTANCE OF 245.24 FEET; THENCE S 0°07'51" E, A DISTANCE OF 75.08 FEET; THENCE N 89°52'09" E, A DISTANCE OF 94.42 FEET; THENCE S 1°45'20" E, A DISTANCE OF 194.14 FEET; S 88°14'26" W, A DISTANCE OF 40.42 FEET; THENCE S 1°45'57" E, A DISTANCE OF 330.05 FEET; THENCE S 19°22'40" W, A DISTANCE OF 302.19 FEET; THENCE S 16°32'24" W, A DISTANCE OF 341.03 FEET; THENCE EASTERLY ON A CURVE TO THE LEFT, SAID CURVE HAVING AN INITIAL TANGENT BEARING OF S 77°49'54" E AND A RADIUS OF 800.00 FEET, AN ARC DISTANCE OF 207.61 FEET; THENCE S 1°26'40" E, A DISTANCE OF 442.54 FEET TO A POINT ON THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 13; THENCE S 87°52'31" W, ALONG THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 13, A DISTANCE OF 508.24 FEET TO THE POINT OF BEGINNING, CONTAINING 628,131 SQUARE FEET OR 14.4199 ACRES, MORE OR LESS

Said legally described property is hereby rezoned from the CTY PEC-3 (County Light Industrial) District to the R-1 (Single Family), R-2 (Two-Family), R-3 (Low-Density Multifamily) and M-2 (General Industrial) Districts.

**SECTION TWO:** That this rezoning is approved with the following stipulation:

1. The following uses are prohibited in the M-2 District:
  - a. Power generation plant
  - b. Parking Lots, Surface, as Principal Use

- c. Public Utility Storage and Service Yards
- d. Automobile Storage or Towing
- e. Paper Manufacturing
- f. Recycling Centers, Drop-Off
- g. Rendering and Meat Byproduct Processing
- h. Petroleum Bulk Stations and Terminals
- i. Storage Area or Lot, except when as an accessory use to a building, and not visible from arterial and collector roadways


2. The R-3 District is limited to a maximum density of 12 dwelling units per acre.

**SECTION THREE:** That Section 18.20.030 of the Unified Development Ordinance, which incorporates by reference the Olathe Zoning Map, is hereby amended by reincorporating by reference the said Zoning Map as it has been amended in Section One of the Ordinance.

**SECTION FOUR:** That this Ordinance shall take effect from and after its passage and publication as provided by law.


