### REQUIREMENTS FOR APPLICATION ONLINE SUBMITTAL AND PERMIT ISSUANCE

The following items are required at the time of application online submittal:

- □ This application to be completed and signed, scanned in PDF format.
- Digital media of the project plans and supporting documentation in PDF format, formatted so that plans may be altered with a City Certified Signature and digitally locked upon completion of the plan review. Plans must be stamped or sealed by Kansas licensed design professional/s <u>and submitted as a collated complete set of drawings</u>. (ALL plan sheets in a single pdf document)
- □ Planning Building Permit Submission Authorization letter for any project that includes in the scope of work any major exterior modifications of the architecture and/or building design.
- □ Statement of Special Inspections.
- □ Johnson County Wastewater Permit, if in Johnson County Wastewater district.
- □ Payment of plan review fees.

The following items are required prior to permit issuance:

- □ The application must be reviewed and approved by all relevant City of Olathe review agencies.
- □ All contractors that are required to be licensed are licensed and in good standing with the Johnson County Contractor Licensing Program.
- Submission to the Building Codes Division of Letters of Intent to perform services from all special inspection agencies that will be providing special inspection services for the project.
- Payment of all fees and taxes, including permit, water/sewer connection, system development and other related fees, as well as any public art excise taxes.
- After plan review is complete and approved, the Building Codes Division will apply a digital stamp that plans were "Reviewed for Code Compliance". These plans must be available on the jobsite in either digital or hard copy format.
